

Riverview High School International Baccalaureate Parent Organization IBPO Board of Directors Meeting August 15, 2023

CALL TO ORDER Meeting was called to order at 10:01 am

ESTABLISH A QUORUM/ROLL CALL

WELCOME BY THE PRESIDENT

President, Melissa Watrobsky, called the meeting to order.

PRINCIPAL'S UPDATE

Principal Haughey reported that Riverview has more students than ever as of today with 2757 students enrolled, which is 100 over normal enrollment. They are currently awaiting approval to hire more teachers. Each lunch period has approximately 900 students & more tables have been added to accommodate them. Open house is on September 13^{th} 6:00 pm – 8:00 pm. Parents will follow their students' schedule with 10 minutes in each class and in the cafeteria for their lunch break.

IB COORDINATORS UPDATE

Dr. Minor reported that Dr. Little has transferred to the position of Director of Transportation for the district. The position has been filled by Jessica Fuesy, a former IB student and graduate of Riverview High School. There are currently 7 Riverview Graduates teaching at Riverview. IB enrollment is approximately 860 students. This year there were approximately 460 applicants for spots in the 9th grade. There are currently 230 students enrolled in the 9th grade IB program. The 2023 IBCP class graduated with a 100% diploma rate which was 80% higher than the national average. 2023 was the first year for Riverview to allow all students to take IB English. The Excellence in Equity program under the Riverview Foundation is for 11th & 12th grade parents to assist students who need additional support. Students receive a Companion with educational support, future assistance for submitting for scholarships, applying to university, and items to assist them once they move into college if needed.

Treasurers Report – Jamie Black

Mrs. Black met with Kim Minor, Accountant for Foundation, to get all financials transferred over and access to the system. She will have up to date financials at the next board meeting. It was noted that the finances and accounting of the IBPO is under the umbrella of the Riverview Foundation a 501(c)3.

PRESIDENTS REPORT - Melissa Watrobsky

President Watrobsky introduced the IBPO Board members and Committee members for 2023 – 2024 (copy attached). Several corrections to the calendar were noted; updated calendar has been added to the website. She is looking into name badges for all new board members. IB teacher training expenses were tabled until September's meeting. President Watrobsky mentioned that gear sales for Orientation went well and reminded everyone that the only two fund raisers, other than donations, for IBPO are gear sales and IBPO memberships which allow us to do things for the students and entire faculty.

MEMBERSHIP REPORT – Kami Yaegers

To date there are 149 members out of over 800 IB student families.

WEBSITE UPDATE - Alice Moe

The committee is currently working on getting the website up to date.

NEW BUSINESS

Fall SAT/ACT Prep Course – IBPO facilitates the course that has been hosted by Wendy Dunn in the past and she is willing to commit to a Fall 2023 course. The Board voted unanimously to hire Ms. Dunn again for the Fall 2023 course. Dates for the course will be October 3, 10, 17 24 & 31st at a cost of \$175.00 per student. Ms. Dunn has not committed to a Spring course yet. Discussion ensued regarding other avenues and instructors for spring. Principal Haughey and Rebecca Lewis commented on the upcoming changes for the SAT/ACT testing. Discussion ensued.
